IMPORTANT NOTICE

Summer 2026 Reservation Policy Updates

To improve fairness, consistency, and the overall guest experience, the following **reservation policy changes** will go into effect for all Summer 2026 stays (**beginning May 15, 2026**).

STAY LIMITS

- **Maximum Stay:** 30 consecutive nights
- **Extended Stay Policy:** Any stay of **21 consecutive nights or more** will require the guest to vacate the park for at least **7 consecutive nights** before returning.

WATERFRONT SITE BOOKING LIMITS

(May 15 – Oct. 14, 2026 Only) Waterfront sites **51–66** and **119–123** will be limited to a **maximum of 14 consecutive nights** during the summer season. Highlighted with blue rectangle below. Note: This rule applies only to these specific waterfront sites during summer months.



SITE OPTIMIZATION – Applies to reservations with arrival dates on or after May 15, 2026

To ensure optimal use of available sites during our busiest season, **site optimization will be in effect starting May 15, 2026**. This allows us to adjust site assignments as needed prior to arrival.



You CAN lock your site! You may purchase a **Site Lock for \$25** to guarantee your selected site will not be moved.

CANCELLATION FEE POLICY

Cancellations 7 or More Days Prior to Arrival:

Stay Length	Fee
1–14 Nights	First Night* + \$10 Booking Fee
Cabins	\$40 + \$10 Booking Fee
15–91 Nights	\$125 + \$10 Booking Fee
Supersites	\$200 + \$10 Booking Fee

Cancellation Within 7 Days of Arrival:

Stay Length	Fee
1–14 Nights	First Night* + \$50 + \$10 Booking Fee
Cabins	First Night + \$10 Booking Fee
15–91 Nights	\$175 + \$10 Booking Fee
Supersites	\$300 + \$10 Booking Fee

*First Night based on full nightly rate at time of cancellation

CHANGES TO RESERVATIONS

- Guests may make **one (1) change** to their original reservation
- A change may reduce the stay by a **maximum of 7 days** from the original reservation dates.
- After one change, further adjustments require a **new reservation and full payment**, including applicable cancellation/rebooking fees
- **Extending the departure date** is **not** considered a change

Changes made within 7 days of arrival will result in a *First Night Fee**

*Based on full nightly rate

RESERVATION MANIPULATION & FAIR USE POLICY

Any attempt to misuse or manipulate the reservation system is considered a **violation of policy**. This includes but is not limited to:

- Shortening reservations to avoid cancellation or minimum stay fees
- Booking under multiple names to bypass stay limits
- Repeated cancellations and rebookings
- Holding sites with no intent to use

Violations will result in immediate cancellation without refund.

Reducing stays to minimize cancellation fees will result in the maximum cancellation fee being assessed.
